## • Is it permissible to retake the final online examination? What are the criteria for eligibility?

Participants who fail the written examination but successfully meet the requirements of the continuous assessment may retake the CQI|IRCA examination once, within a 12-month period from the original training date. In contrast, students who do not pass the continuous assessment will not be permitted to retake the final online examination and will be required to complete the full course again.
